When visiting the website, information may be collected automatically, including:

- IP Address
- Browser Type
- Device Information
- Website Usage Data
- Cookies and Similar Technologies

3. HOW INFORMATION IS USED

CUKC may use information to:

- Process applications and registrations
- Maintain registry records

- Verify ownership and pedigree information
- Process memberships
- Communicate with members and applicants
- Provide customer support
- Administer events and programs
- Improve website functionality
- Comply with legal obligations
- Protect the integrity of the registry

4. INFORMATION SHARING

CUKC does not sell personal information.

Information may be shared when necessary:

- To process registry services
- To verify registrations and ownership records
- To comply with legal requirements
- To protect CUKC rights and interests
- With service providers assisting CUKC operations

Registry information appearing on certificates, pedigrees, and verification systems may be publicly accessible where applicable.

5. DATA SECURITY

CUKC shall take reasonable measures to protect information from:

- Unauthorized access
- Unauthorized disclosure
- Alteration
- Misuse
- Loss

No electronic system can guarantee absolute security.

6. RECORD RETENTION

CUKC may retain records indefinitely for:

- Registry Integrity
- Historical Purposes
- Pedigree Verification
- Ownership Verification
- Administrative Requirements

- Legal Compliance

7. COOKIES AND WEBSITE TECHNOLOGIES

The CUKC website may use cookies and similar technologies to:
